Dear Planning Board Members:

I am sorry that, due to the icy road conditions, I will be unable to attend today's workshop.

As you know, I have been participating in the MMC Expansion Group for over a year, representing Western Prom Neighborhood Association. This comment however is being made personally, not for that organization.

1) I am concerned, as has been expressed by staff, about the choice of the color white for the façade of the East Tower addition. While I appreciate the architects' "Sky, Sea, and Land" design concept, it seems to me that the massive white metal wall will be glaringly institutional and will not visually blend with the brick below. I am not advocating for brick, but for a more recessive color or different material (e.g. copper). While white panels frame the existing windows below, it seems to me a more compatible color and/or material would not be the jarring counterpoint that the proposed white panels present. As noted by staff, this issue is especially important if this design approach informs future choices in later phases.

2) Almost everyone acknowledges that it has been a disappointment that the Congress Street retail space has been vacant since it was partially finished many years ago. I understand that the space will be used for construction purposes. But I think it is essential to establish a requirement that a use be in place in that space within so many months after the project completed or a penalty of some sort will be assessed. While not an ideal space, especially in its unfinished condition, there must be some viable use for that space that will enliven the street, as required in the IDP!

3) I think it is very important to develop a realistic detour plan for Congress Street during the time it is closed during construction. The initial detour plan to divert traffic within the neighborhood does not make any sense, in my view. Unlike the debacle on State Street during the recent closure, the City should affirmatively direct traffic to a well-developed detour route, not just leave the heavy volume of traffic that uses Congress Street to find its own way...

Hi there,

I am working late this evening and can't make the meeting, but I'd love to learn more - I'll be reading through the materials as they're posted.

I've heard that MMC is planning to expand in place, and I have some questions about the plans for keeping the area accessible to both patients and staff. I understand having the emergency department right in town, but I don't see why the rest of the hospital needs to take over any more space in the west end. Portland is becoming so overcrowded and the park there is one of the few green spaces with a nice view that's staying untouched. Aside from views and grass, as someone who contracts weekly at the hospital I find it frustrating to find parking each week when I'm seeing clients. Employees there can park at the satellite lot and bus in- if you have an 8 hour shift, that's fine. But for short shifts, when we need to get in and out quickly to see clients elsewhere, there is only limited street parking up to two hours. The hospital garage is almost always full, particularly in the winter when residents seem to be using it for personal use.

I'm lucky enough to be healthy enough to park farther away and walk, but there are patients and families who have similar trouble finding parking and access to the hospital.

I hope there is a plan in place to remedy this situation in the long term, but more so in the short term - while construction is happening, where will all those cars go?
