**TERMS OF AGREEMENT  
FOR RENTAL OF DINGHY/KAYAK STORAGE RACK - EAST END BOAT LAUNCH**

1. Cost of one rental rack space is \$200 from May 1 – November 1, 2011. Prorated cost will be \$50 per month or any part of a month after July 1, 2011. Rental must be paid in full, prior to the start of storage thru November 1, 2011.
2. Non-residents of Portland will pay an additional fee of \$50 per season/\$250.00. A prorated cost of \$65 a month or any part of a month after July 1, 2011
3. Rack rental is on a first come, first serve basis. Upon receipt, slots will be assigned by number. Before placement of dinghy/kayak, Owner must attach Registration Sticker along the port side of dinghy/kayak.
4. Owner agrees to remove dinghy/kayak by **November 1, 2011**. Failure to remove dinghy/kayak from rack by date Stated will result in the inability to rent during subsequent seasons.
5. Owner must ensure the dinghy/kayak is reasonably secured in its assigned rack space and will not pose any danger to any passers by. Owner must provide locking mechanism.
7. Owner must ensure the dinghy/kayak rack space is clean and tidy at all times. Nothing other than one dinghy/kayak can be left on, in, around or by the rack at any time.
7. The storage rack unit may only be used for the one dinghy/kayak listed above.
- 8. Owner acknowledges that dinghy/kayak storage rack rental is at their own risk. The City of Portland accepts no responsibility for loss of or damages to the dinghy/kayak. Failure to comply with above terms will result in termination of this agreement with no refund of rental fees.**

**I agree to abide by the rules and regulations stated above and I hold myself solely responsible for any mishap/injury or damage to the dinghy/kayak listed above.**
