**REQUIREMENTS per City Code of Ordinance Chapter 28. Section 91:**

**A. DOCUMENTS TO BE PRESENTED WITH THIS APPLICATION**

1. Must show Valid Maine **Driver's License & Registration**, reflecting applicants address within the zone and with the name of applicant on the Registration (**Exceptions** a,b below)
  - a. Students must show student I.D. from a school located in Portland, in addition to Driver's License
  - b. Military must show military I.D. in addition Driver's License
  - c. For proof of residency from a & b above, applicants must provide a lease, recent utility bill, voter registration card or **document verifying residency within the zone** approved by the Parking Manager.

**NOTE:** Individuals who have a Portland P.O. Box as an address on their License, will be required to show their Portland address within the zone on two of the following a lease, tax bill, and or a utility bill.

**B. ALL OUTSTANDING PARKING TICKETS MUST BE PAID IN FULL.**

\*There is no fee for this sticker for those who fit the requirements above. However, there is a \$50.00 fee per vehicle per year for Portland Property owners whose license & registration show a non-Portland address. Applicant must show a tax bill for property inside the zone and reside at the address at least 5 months per year.

**C. THE STICKER MUST BE PLACED IN THE BOTTOM CENTER OF THE REAR WINDOW.** If the window is tinted, or the vehicle has a removable top or cap-place the sticker in the lower driver's side corner of the windshield.

**IF THE STICKER IS NOT IN THE EXACT PLACE, YOU ARE SUBJECTED TO BEING TICKETED**

**WHAT DOES THIS STICKER ALLOW ME TO DO?**

- You may park all day in the one or two- hour on street spaces within your zone,  
 These spaces are marked with Green & White signs which normally allow only one or two hour parking.
- You must obey all other posted parking or no parking signs and regulations.  
 This sticker is **not valid at** parking meters, no parking zones, overnight parking, 15 and 30 minute zones, commercial zones, day or night street maintenance restrictions, emergency no parking signs, snow bans, etc.

**NOTE! EMERGENCY NO PARKING TOW AWAY SIGNS MAY BE POSTED ON YOUR STREET 12 HRS IN ADVANCE OF THEIR EFFECTIVE DATE.**

No person shall furnish any false information to the City of Portland in connection with obtaining any permit or said permit shall become null and void. Only one permit shall be valid at any one time; all price permits should be removed.
