## **Building Construction Codes and Standards**

*The Permitting and Inspections Department is responsible for administering and enforcing building and construction codes. The City of Portland has adopted the following codes and standards:*

Effective January 23, 2018, the State of Maine adopted the statewide Maine Uniform Building and Energy Code (MUBEC) which consists of four International Code Council (ICC) codes and four standards.

Effective December 5, 2019, the City of Portland has adopted the 2018 versions of the National Fire Protection Association (NFPA) Life Safety Code (NFPA 101) and Fire Code (NFPA 1).
